Once this tooling is completed, and after samples (made using this tooling) have been accepted by Chalmers Suspensions International Inc. and the tooling paid for in full, the said Bailee agrees that in consideration of being allowed to use the said tooling described above to comply with the following terms and conditions:

- 1. The Bailee shall use all reasonable care to protect and preserve the goods and materials hereinbefore described from loss or damage and shall be liable for any such loss or damage which may occur.
- 2. All work to be done by the Bailee on behalf of Chalmers Suspensions International Inc. shall be done in a good workman like manner in strict accordance with the plans, blueprints, and specifications furnished to the Bailee while such Bailee is using the goods and material hereinbefore described.
- 3. The Bailee agrees to tag or stamp the said goods and materials as being the property of Chalmers Suspensions International Inc.
- 4. The Bailee agrees to keep the said goods and material fully insured or self-insured at his own expense or so long as they shall have possession of the Bailer's property to an amount not less than the full insurable value thereof with loss, if any, payable to Chalmers Suspensions International Inc. The undersigned with forthwith on demand obtain and deliver evidence of such insurance.
- 5. The Bailee agrees to use or operate the said goods and materials for no other purpose than authorized in writing by Chalmers Suspensions International Inc.
- 6. The Bailee agrees to release Chalmers Suspensions International Inc. from all claims for damages or otherwise in any manner whatsoever arising out or connected with the said bailment and to indemnity and save it harmless of and from all loss, costs and damages arising out of or connected with the said bailment whether such loss, costs or damages result from the negligence of the Bailee or otherwise unless due to the negligent or willful conduct of Chalmers Suspensions International Inc., its agents, employees or contractors.
- 7. The Bailee agrees to return the said goods and materials to Chalmers Suspensions International Inc. on demand at the expense of Chalmers Suspensions International Inc., and acknowledge that he has no right in the said goods and material and will not encumber them in any manner whatsoever. The Bailee agrees that Chalmers Suspensions International Inc. shall have the right to enter the premises of the Bailee to repossess and remove the goods at any time upon one day's notice.
- 8. The terms and conditions of this Bailee Receipt shall inure to the benefit of and be binding upon the parties hereto, their heirs, executors, administrators, associates and assigns respectively, and shall remain in full force and effect until which goods and material have been returned to Chalmers Suspensions International Inc.
- 9. Pictures of tooling / fixtures / inspection gauges are required to be sent to Chalmers for the record.
